Ordinance 2009-08 of Minneola, Florida provides for local implementation of the water conservation rule for landscape irrigation of the St. Johns' River Water Management District effective 4/29/09. Everyone within the City of Minneola is urged to conserve water in every way possible, in homes and businesses. Everyone is urged to avoid unnecessary irrigation of landscaping.

The following irrigation rules apply **effective 4/29/09**:

1. Irrigation is not permitted between the hours of 10:00 AM and 4:00 PM.
2. Irrigation Days:
Daylight Savings (2nd Sunday in March to the 1st Sunday in November)
Odd Addresses (addresses ending in 1,3,5,7 and 9) Wednesday & Saturday
Even Addresses (addresses ending in 0,2,4,6 and 8) Thursday & Sunday

Eastern Standard Time (1st Sunday in November to 2nd Sunday in March)
Odd Addresses Saturday
Even Addresses Sunday
3. Irrigation shall be limited to the application of no more than $\frac{3}{4}$ of water in irrigated area.
4. New landscaping may be irrigated on any day at any time during the first 30 days and every other day for the next 30 days, for a total of one 60 day period, providing that the irrigation is limited to the minimum amount necessary for such landscape establishment.
5. Low-volume irrigation is permitted anytime with a hand-held hose equipped with an automatic shutoff nozzle.

Violation of the above rules shall be subject to penalties.

Dear New Resident:

We would like to take this opportunity to welcome you to the City of Minneola and inform you of some of the operating procedures of our City.

Minneola is governed by a City Manager, a Mayor and four (4) City Council members. City Council meetings are held the first and third Tuesday of each month at Minneola City Hall located at 800 N. Highway 27 at 6:30 PM. The public is invited to attend these meetings.

The City Park is located south of Madison Street and connects with the Minneola Scenic Trail. The park includes a paved parking area, restrooms, a covered pavilion, playground area, a pedestrian corridor that connects with the Minneola Scenic Trail, two softball fields and a basketball court are available.

Water service is provided by the City of Minneola. Water bills are processed in 2 cycles and mailed by the 1st and 15th of every month. Bills not paid by the 10th day after the bill dates are subject to a late charge. There are night deposit boxes located at both the front and rear of the building. **Accounts not paid by the 20th day after the bill dates are subject to disconnection.** There will be a \$10.00 charge to turn water on and a \$10.00 charge to turn water off. **PLEASE NOTE: If you have an irrigation/sprinkler system, re-set to avoid excessive use and high water bills.**

Sanitary Waste Services are provided to City residents. The charge is included with water billing. Services are provided on Monday and Thursday of each week if you live East of Highway 27 and on Tuesday and Friday if you live West of Highway 27. The size of your garbage container cannot be larger than 32 gallons. Household garbage must be bagged and in cans. Recyclables are limited to: newspaper, metal cans, plastic bottles and jugs, and clear glass jars with labels removed. Yard waste and recycling will be picked up on Wednesdays. Yard waste must be cut to 4' or less and bundled. Grass clippings must be bagged and placed at the curb. Garbage service is provided for the Reserve and Ridgecrest Loop on Thursdays. For bulk pick-up you must call 800-640-6875.

Minneola's law enforcement is provided by the Lake County Sheriff's Office. Fourteen (14) full-time officers are assigned to our City. For non-emergencies please call 343-2101. As with all emergencies, dial 911.

The Minneola Fire Rescue Department is proud to serve the Minneola community. We have thirteen (13) full time personnel. The Fire Station is located at 811 S. Galena Avenue. We would be happy to show you around the station, apparatus and equipment. You can stop by anytime during business hours for a tour. For non-emergencies call 352-394-6811 and as with all emergencies please call 911.

Residents of the City of Minneola are in voting Precinct 22, located at City Hall at 800 N. Highway 27.
