5 The City of Minneola Workshop was called to order by Mayor Pat Kelley.

7 Present were: Councilman Rick Roderick, Councilman Joseph Saunders, Acting City
8 Manager Jan McDaniel, Finance Director Laura Zielonka, Attorney Scott Gerken.
9 Councilman Ortega was absent.

10
11 **Jan McDaniel** opened the meeting by stating that she had been advised by the City
12 Attorney that there was a need to approve an Interlocal service boundary agreement at
13 this meeting.

14
15 **Scott Gerken** explained the item to Council including that there would need to be a
16 liaison appointed to the committee and read Resolution 2010-05 by title only.

18 **MOTION by Kelly Price, SECONDED by Rick Roderick to approve Resolution**
19 **2010-05.**

21 **Joe Saunders** asked if there were any issues. *Scott Gerken explained the issues were*
22 *stated in the state statute included in the exhibit.*

28 **MOTION PASSED: 4-0**

30 **Mayor Kelley** then asked that the members of the sheriff's department come up to the
31 table.

33 **Jan McDaniel** explained the purpose of the workshop was to discuss a possibility of cost
34 reduction to the FY11 LCSO Contract.

35
36 Sheriff Gary Borders, Captain Peyton Grinnell, Lt. Greg Link and Major Gerry Montalvo
37 joined the Council at the table.

39 **Jan McDaniel** explained that she had spoken with Lt. Link recently and asked him what
40 amount of services could be provided for \$1,000,000.00. She stated that following some
41 research she had found how the City had reached the status of 14 deputies, one
42 Lieutenant, one Sergeant and a clerk. She asked those present to please consider ways to
43 trim the contract amount.

45 **Sheriff Borders** spoke on the current contract amount and actual cost of those services
46 and the level of service provided

14 **Jan McDaniel** asked that the Sheriff and the City work together.

16 **Final Council Comments:**

17 **Rick Roderick** stated his opinion was to cut the contract by \$400,000.00

18 **Kelly Price** asked for a compromise.

19 **Joe Saunders** expressed concern with more city layoffs and asked that the Sheriff
20 consider cutting the contact costs at least \$300,000.00 from the contract cost.

21 **Mayor Kelley** suggested coming back with the cost cuts from \$100,000.00 to
22 \$200,000.00. He stated the burden would be on the Council to decide what services they
23 wanted.

24
25 Council continued to discuss possible cuts to staff and/or services.

26
27 **Sheriff Borders** stated his department was here to provide a service, agreed to work with
28 the numbers and that he would get back to the City.

29
30 **MOTION by Rick Roderick, SECONDED by Kelly Price to adjourn.**





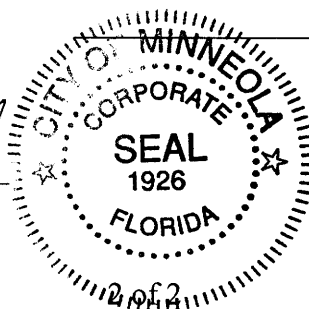
