

**Minneola Budget Hearing

The City of Minneola Budget Hearing was called to order by Vice Mayor Pam Serviss. Also present were Councilor Lisa Jones, Councilor Kelly Price, Councilor Joe Saunders, Scott Gerken (City Attorney), Mark Johnson (City Manager), and Barbara Hollerand (City Clerk). Mayor Pat Kelley was absent.
