The current year rollback 22 rate is 6.1341. The current year final millage rate is less than the current year rollback rate. 23 24 Scott Gerken read Resolution No. 2020-16 by title only. 25 Mark Johnson presented the budget and explained it was unchanged from the one presented at 26 27 the first hearing.
