RESIDENTIAL PERMIT FEE SCHEDULE (Revised 2/7/12)

Value of construction for permits will be determined by the most recent publishing of the International Code Council Building Safety Journal, building valuation data (cost per square foot), of all areas under roof according to the type of construction and use.

NOTE: ALL PLAN REVIEW FEES ARE DUE AT THE TIME OF SUBMITTAL
