### Parade Rules:

**Hold Harmless Waiver:** The City of Minneola requires all parade participates to sign a Hold Harmless Agreement. The Hold Harmless Agreement is a separate document along with the application. The application and Hold Harmless Agreement must be turned in together.

### Staging:

Parade Line Up starts at 4:00 p.m. Everyone needs to be in place by 5:00 p.m. as the parade starts at 6:00 p.m. Entry Point - Please be sure to check in with the parade officials. Do not park or loiter in the middle of road. Walkers can stand on the sidewalks and trail.

**Illumination:** The City of Minneola Parade is at night. Therefore, all floats are required to be illuminated and all participants are expected to wear some type of illumination device while on the parade route.

**<u>Animals</u>**: Live Animals are permitted but must be approved by parade organizer. You must have a walker to clean up behind the animals.

**<u>Favors</u>**: Tossing items (including candy) from any part of the entry **is prohibited** on the parade route during the parade. Favors may be handed out by walkers wearing masks or face shields and gloves along the edge of the parade route.

**<u>Float Size:</u>** Float sizes are as follows: 8 ft. – 12 ft. (width), 16 ft. – 64 ft. (length), and a maximum of 13.5 ft. (height).

**Floats/Tow Units:** It is recommended that the tow vehicle be a four-wheel drive vehicle. All tow vehicles should be decorated accordingly.

**Spotters:** All Floats and Motorized vehicles must have a spotter walking alongside the vehicle for the entire parade route.

<u>Santa or Mrs. Claus:</u> Mr. and Mrs. Claus will make their appearance at the end of the parade. Therefore, no other Santa is allowed.

**Parade End Directions:** Keep moving on Main Ave to Lake Minneola Dr. unless you need to drop off float participates and or have walkers in the parade. Post Parade, all walkers and float participate drop offs can wait to be picked up at the post Staging Lot at Main Ave and W Silverton in the empty lot with the gazebo. This is standing room only. Parents can walk to this lot to pick up participates. For your safety no parking is allowed on this lot.
