2023 MAYOR'S PROCLAMATION

THE GENERAL ELECTION OF THE CITY OF MINNEOLA SHALL BE HELD IN MINNEOLA CITY HALL, LOCATED AT 800 NORTH U.S. HIGHWAY 27, MINNEOLA, FL, ON TUESDAY NOVEMBER 7, 2023, BETWEEN THE HOURS OF 7:00 A.M. AND 7:00 P.M. EASTERN STANDARD TIME.

THE PURPOSE OF THE ELECTION IS TO ELECT A CANDIDATE FOR CITY COUNCIL SEAT 1, SEAT 3, AND SEAT 5 AND TO PRESENT BALLOT QUESTION NUMBER 1 AND BALLOT QUESTION NUMBER 2 REGARDING TERM LENGTH AND TERM LIMITS.

THE OFFICE HOLDS A TWO-YEAR TERM FROM NOVEMBER 2023 TO NOVEMBER 2025.

THE BALLOT QUESTION ON THE BALLOTS ARE AS FOLLOWS:

BALLOT QUESTION NUMBER 1:

CURRENTLY, THE CITY CHARTER PROVIDES FOR ANNUAL CITY COUNCIL ELECTIONS AND STAGGERED TWO-YEAR TERMS OF OFFICE. THE PROPOSED AMENDMENT INCREASES THE TERM FROM 2 TO 4 YEARS AND PROVIDES STAGGERED FOUR-YEAR TERMS OF OFFICE. IF THE AMENDMENT IS APPROVED, COUNCIL SEATS 1, 3, AND 5 SHALL BE UP FOR RE-ELECTION FOR A FOUR-YEAR TERM STARTING IN NOVEMBER 2026 AND SEATS 2 AND 4 SHALL BE UP FOR RE-ELECTION FOR A FOUR-YEAR TERM STARTING IN NOVEMBER 2024.

BALLOT QUESTION NUMBER 2:

CURRENTLY, THE CITY CHARTER CONTAINS NO CITY COUNCIL TERM LIMITS. THE PROPOSED AMENDMENT PROVIDES FOR A TERM LIMIT OF EIGHT YEARS AND SIXTY DAYS BEGINNING AFTER THE NOVEMBER 2023 ELECTION. THE PROPOSED AMENDMENT ALLOWS SOMEONE WHO WOULD OTHERWISE NOT QUALIFY TO SERVE ON CITY COUNCIL DUE TO SUCH TERM LIMIT TO SIT OUT ONCE FOR AN INTERVENING TERM OF OFFICE AND THEREAFTER QUALIFY FOR ONE ADDITIONAL MAXIMUM OF EIGHT YEARS AND SIXTY DAYS ON CITY COUNCIL.
